CONSULTATION DRAFT

ONTARIO REGULATION TO BE MADE UNDER THE HIGHWAY TRAFFIC ACT AMENDING REG. 628 OF R.R.O. 1990 (VEHICLE PERMITS)

- 1. (1) The definition of "emissions inspection report" in subsection 1 (1) of Regulation 628 of the Revised Regulations of Ontario, 1990 is revoked.
- (1.1) Subsection 1 (1) of the Regulation is amended by adding the following definition:

"heavy diesel commercial motor vehicle" means a commercial motor vehicle that,

- (a) has a registered gross weight more than 4,500 kilograms, and
- (b) operates on diesel fuel;
- (1.2) The definition of "hybrid vehicle" in subsection 1 (1) of the Regulation is revoked.
- (2) The definition of "registered gross weight" in subsection 1 (1) of the Regulation is revoked and the following substituted:

"registered gross weight" means the weight for which a permit is issued; ("poids brut enregistré")

(3) Subsection 1 (1) of the Regulation is amended by adding the following definition:

"vehicle emissions report" has the same meaning as in [***Reg***] (Emissions from Motor Vehicles) made under the Environmental Protection Act;

- 2. (1) Clause 2 (1) (b) of the Regulation is revoked and the following substituted:
 - (b) if the application is in respect of a heavy diesel commercial motor vehicle, that the Ministry is satisfied that a vehicle emissions report indicating a pass has been issued in respect of the vehicle within the previous 12 months.

- (1.1) Subsection 2 (2) of the Regulation is amended by striking out the portion before clause (a) and substituting the following:
- (2) Clause (1) (a) does not apply, and, with respect to applications for a permit before the seventh calendar year after a vehicle's model year, clause (1) (b) does not apply,
 - (1.2) Subsection 2 (2.1) of the Regulation is revoked.
 - (2) Subsection 2 (5.1) of the Regulation is revoked and the following substituted:
- (5.1) Clause (1) (b) does not apply in respect of a current model year motor vehicle or a future model year motor vehicle.
 - (3) Subsection 2 (6) of the Regulation is revoked.
- (4) Clause 2 (9) of the Regulation is amended by striking out "emissions inspection report" and substituting "vehicle emissions report indicating a pass".
 - (5) Section 2 of the Regulation is amended by adding the following subsection:
- (10.1) Despite anything in this section, a permit may be issued and evidence of validation furnished without the required vehicle emissions report indicating a pass if the Ministry is notified by the Director, within the meaning of the Environmental Protection Act, that it is not reasonably possible to test the vehicle.
- 2.1 Subsection 5.1 (3) is amended by striking out "Subject to subsection (2), a permit" at the beginning and substituting "A permit".
- 3. (1) Subsections 8.2 (1) and (1.1) of the Regulation are revoked and the following substituted:
- (1) This section applies to applications for the renewal of a motor vehicle permit for heavy diesel commercial motor vehicles.
- (2) Subsection 8.2 (2) of the Regulation is amended by striking out "emissions inspection report" and substituting "vehicle emissions report indicating a pass".
- (3) Subsections 8.2 (4) to (8) of the Regulation are revoked and the following substituted:
- (4) Despite anything in this section, a permit may be renewed or validated without the required vehicle emissions report indicating a pass if the Ministry is notified by the Director, within the meaning of the Environmental Protection Act, that it is not reasonably possible to test the vehicle.
