#### AMENDED ENVIRONMENTAL COMPLIANCE APPROVAL

You have applied under section 20.2 of Part II.1 of the <u>Environmental Protection Act</u>, R.S.O. 1990, c. E. 19 (Environmental Protection Act) for approval of:

#### **Equipment Located in Building "A"**

- two (2) open face paint spray booths, each equipped with dry type paint arrestor filter with a filter area of 3.87 square metres, discharging to the air though dedicated stacks (Stack IDs EX-2 and EX-3), each having a volumetric flow rate of 3.7 actual cubic metres per second, exit diameter of 0.61 metre, extending 2.3 metres above the roof and 8.3 metres above grade;
- one (1) open face paint spray booth, equipped with dry type paint arrestor filters, totalling a filter area of 4.84 square metres, discharging to the air at a volumetric flow rate of 3.7 actual cubic metres per second, through a stack (Stack ID EX-4), having an exit diameter of 0.61 metre, extending 6.0 metres above the roof and 12 metres above grade;
- one (1) open face paint spray booth, equipped with dry type paint arrestor filters, totalling a filter area of 4.84 square metres, exhausting into the atmosphere at a volumetric flow rate of 4.72 actual cubic metres per second, through a stack (Stack ID EX-5), having an exit diameter of 0.61 metre, extending 6.0 metres above the roof and 12 metres above grade;

- one (1) closed face paint spray booth, equipped with dry type paint arrestor filters, totalling a filter area of 4.84 square metres, exhausting into the atmosphere at a volumetric flow rate of 8.5 actual cubic metres per second, through a stack (Stack ID EX-6), having an exit diameter of 0.9 metre, extending 6.0 metres above the roof and 12 metres above grade;
- one (1) natural gas fired curing oven having a maximum thermal input of 1,055,000 kilojoules per hour, discharging to the air at a volumetric flow rate of 4.72 actual cubic metres per second, through a stack (Stack ID EX-7), having an exit diameter of 0.31 metre, extending 4.5 metres above the roof and 10.5 metres above grade;
- one (1) natural gas fired curing oven having a maximum thermal input of 844,000 kilojoules per hour, discharging to the air at a volumetric flow rate of 1.18 actual cubic metres per second, through a stack (Stack ID EX-8), having an exit diameter of 0.31 metre, extending 2.7 metres above the roof and 8.7 metres above grade;
- silk screening and pad printing operations discharging with the the building envelope; and
- one (1) paint storage room, discharging to the air at a volumetric flow rate of 1.18 actual cubic metres per second, through a horizontal vent, having an exit diameter of 0.3 metre, extending 2.5 metres above grade;

## Equipment Located in Building "B"

- one (1) parts washer for the application of phosphoric acid solution, discharging to the air at a volumetric flow rate of 0.31 actual cubic metres per second, through a stack (Stack ID EX-1), having an exit diameter of 0.31 metre, extending 1.02 metres above the roof and 7.03 metres above grade;
- two (2) powder coating booths, equipped with 3-stage filtration PAINT POCKET premium poly arrestors and deep final Poly Bag filter (primary, secondary, and final bag filter), totalling a filter area of 7.2 square meters, discharging within the building envelope; and
- one (1) natural gas fired curing oven, having a maximum thermal input of 1,055,000 kilojoules per hour, discharging to the air at a volumetric flow rate of 4.72 actual cubic metres per second, through a stack (Stack ID EX-9), having an exit diameter of 0.31 metre, extending 2.7 metres above the roof and 8.7 metres above grade;

all in accordance with the application for an *Approval* submitted by Versatile Spray Painting Ltd., dated July 18, 2019 and signed by Chris Heslin; and the supporting information, including the Emission Summary and Dispersion Modelling Report, submitted by EXP Services Inc., dated July 17, 2019 and signed by Ron Taylor and Chris Heslin and revised air emissions and dispersion modelling information submitted by EXP Services Inc. dated June 9, 2020, June 12, 2020, August 24, 2020 and August 28, 2020.

For the purpose of this environmental compliance approval, the following definitions apply:

- 1. "*Approval*" means this Environmental Compliance Approval, including the application and supporting documentation listed above;
- 2. "*Company*" means Versatile Spray Painting Ltd., that is responsible for the construction or operation of the *Facility* and includes any successors and assigns;
- 3. "*District Manager*" means the District Manager of the appropriate local district office of the *Ministry*, where the *Facility* is geographically located;
- 4. "EPA" means the Environmental Protection Act, R.S.O. 1990, c.E.19, as amended;
- 5. "*Equipment*" means the equipment described in the *Company* 's application, this *Approval* and in the supporting documentation submitted with the application, to the extent approved by this *Approval;*
- 6. "Facility" means the entire operation located on the property where the Equipment is located;
- 7. "*Manual*" means a document or a set of documents that provide written instructions to staff of the *Company;*
- 8. "*Ministry*" means the ministry of the government of Ontario responsible for the *EPA* and includes all officials, employees or other persons acting on its behalf;
- "Publication NPC-300" means the Ministry Publication NPC-300, "Environmental Noise Guideline, Stationary and Transportation Sources – Approval and Planning, Publication NPC-300", August 2013, as amended.

You are hereby notified that this environmental compliance approval is issued to you subject to the terms and conditions outlined below:

# **TERMS AND CONDITIONS**

#### **1. OPERATION AND MAINTENANCE**

- 1. The *Company* shall ensure that the *Equipment* is properly operated and maintained at all times. The *Company* shall:
  - a. prepare, not later than three (3) months after the date of this *Approval*, and update, as necessary, a *Manual* outlining the operating procedures and a maintenance program for the *Equipment*, including:
    - i. routine operating and maintenance procedures in accordance with good engineering practices and as recommended by the *Equipment* suppliers;

- ii. emergency procedures, including spill clean-up procedures;
- iii. procedures for any record keeping activities relating to operation and maintenance of the *Equipment;*
- iv. all appropriate measures to minimize noise and odorous emissions from all potential sources; and
- v. the frequency of inspection and replacement of the filter material in the Equipment;
- b. implement the recommendations of the Manual.

## 2. RECORD RETENTION

- 1. The *Company* shall retain, for a minimum of two (2) years from the date of their creation, all records and information related to or resulting from the recording activities required by this *Approval*, and make these records available for review by staff of the *Ministry* upon request. The *Company* shall retain:
  - a. all records on the maintenance, repair and inspection of the Equipment; and
  - b. all records of any environmental complaints, including:
    - i. a description, time and date of each incident to which the complaint relates;
    - ii. wind direction at the time of the incident to which the complaint relates; and
    - iii. a description of the measures taken to address the cause of the incident to which the complaint relates and to prevent a similar occurrence in the future.

#### **3. NOTIFICATION OF COMPLAINTS**

- 1. The *Company* shall notify the *District Manager*, in writing, of each environmental complaint within two (2) business days of the complaint. The notification shall include:
  - a. a description of the nature of the complaint; and
  - b. the time and date of the incident to which the complaint relates.

#### 4. NOISE

1. The *Company* shall, at all times, ensure that the noise emissions from the *Facility* comply with the limits set out in *Ministry Publication NPC-300*.

The reasons for the imposition of these terms and conditions are as follows:

- 1. Condition No. 1 is included to emphasize that the *Equipment* must be maintained and operated according to a procedure that will result in compliance with the *EPA*, the Regulations and this *Approval*.
- 2. Condition No. 2 is included to require the *Company* to keep records and to provide information to staff of the *Ministry* so that compliance with the *EPA*, the Regulations and this *Approval* can be verified.
- 3. Condition No. 3 is included to require the *Company* to notify staff of the *Ministry* so as to assist the *Ministry* with the review of the site's compliance.
- 4. Condition No. 4 is included to provide the minimum performance requirements considered necessary to prevent an adverse effect resulting from the operation of the *Facility*.

# Upon issuance of the environmental compliance approval, I hereby revoke Approval No(s). 5344-8X9LAR issued on August 31, 2012.

In accordance with Section 139 of the Environmental Protection Act, you may by written Notice served upon me, the Environmental Review Tribunal and in accordance with Section 47 of the Environmental Bill of <u>Rights, 1993</u>, the Minister of the Environment, Conservation and Parks, within 15 days after receipt of this Notice, require a hearing by the Tribunal. The Minister of the Environment, Conservation and Parks will place notice of your appeal on the Environmental Registry. Section 142 of the Environmental Protection Act provides that the Notice requiring the hearing shall state:

- a. The portions of the environmental compliance approval or each term or condition in the environmental compliance approval in respect of which the hearing is required, and;
- b. The grounds on which you intend to rely at the hearing in relation to each portion appealed.

Pursuant to subsection 139(3) of the Environmental Protection Act, a hearing may not be required with respect to any terms and conditions in this environmental compliance approval, if the terms and conditions are substantially the same as those contained in an approval that is amended or revoked by this environmental compliance approval.

#### The Notice should also include:

- 1. The name of the appellant;
- 2. The address of the appellant;
- 3. The environmental compliance approval number;
- 4. The date of the environmental compliance approval;
- 5. The name of the Director, and;
- 6. The municipality or municipalities within which the project is to be engaged in.

#### And the Notice should be signed and dated by the appellant.
