You have applied under section 20.2 of Part II.1 of the Environmental Protection Act, R.S.O. 1990, c. E. 19 (Environmental Protection Act) for approval of:

 one (1) venturi scrubber used to control emissions from the tire recycling process (including rough shredding, mid-stream grinding, granulating, screening, grinding, residual fibre separation and bagging, crumb rubber packaging, and all material handling points), consisting of a cyclone, blower and pump, with a scrubber and mist collection house, discharging to the air at a maximum volumetric flow rate of 7.55 actual cubic metres per second, through a stack having an exit diameter of 0.91 metre, extending 6.4 metres above grade;

all in accordance with the Application for Environmental Compliance Approval submitted by Environmental 360 Solutions Ltd. dated January 12, 2021 and signed by Donato Ardellini, Director and all supporting information prepared by Trinity Consultants including the additional information provided by Betsy Varghese, Dillon Consulting Limited, dated February 4, 2022, and the Acoustic Assessment Report dated January 5, 2022, prepared by Ramesh Sivasenthinathan of Trinity Consultants Ontario Inc.

For the purpose of this environmental compliance approval, the following definitions apply:

 "Acoustic Assessment Report" means the report, prepared in accordance with Publication NPC-233, by Ramesh Sivasenthinathan of Trinity Consultants Ontario Inc. and dated January 5, 2022 submitted in support of the application, that documents all sources of noise emissions and Noise Control Measures present at the Facility;

- 2. "Approval" means this Environmental Compliance Approval, including the application and supporting documentation listed above;
- 3. "Best Management Practices Plan" means a document or a set of documents which describe measures to minimize dust emissions from the Facility and/or Equipment;
- 4. "Company" means Environmental 360 Solutions Ltd. that is responsible for the construction or operation of the Facility and includes any successors and assigns in accordance with section 19 of the EPA;
- 5. "District Manager" means the District Manager of the appropriate local district office of the Ministry, where the Facility is geographically located;
- 6. "EPA" means the Environmental Protection Act, R.S.O. 1990, c.E.19;
- 7. "Equipment" means the equipment described in the Company's application, this Approval and in the supporting documentation submitted with the application, to the extent approved by this Approval;
- 8. "Facility" means the entire operation located on the property where the Equipment is located;
- 9. "Manual" means a document or a set of documents that provide written instructions to staff of the Company;
- 10. "Ministry" means the ministry of the government of Ontario responsible for the EPA and includes all officials, employees or other persons acting on its behalf;
- 11. "Noise Control Measures" means measures to reduce the noise emissions from the Facility and/or Equipment including, but not limited to, silencers, acoustic louvres, enclosures, absorptive treatment, plenums and barriers, described in the Company's application, Schedule A of this Approval and in the supporting documentation referred to herein, including the Acoustic Assessment Report, to the extent approved by this Approval;
- 12. "Publication NPC-233" means the Ministry Publication NPC-233, "Information to be Submitted for Approval of Stationary Sources of Sound", October, 1995 as amended;
- 13. "Publication NPC-300" means the Ministry Publication NPC-300, "Environmental Noise Guideline, Stationary and Transportation Sources Approval and Planning, Publication NPC-300", August 2013, as amended;
- 14. "Technical Bulletin: Management Approaches for Industrial Fugitive Dust Sources" means the Ministry publication "Technical Bulletin: management approaches for industrial fugitive dust sources", March 8, 2017, as amended;

You are hereby notified that this environmental compliance approval is issued to you

subject to the terms and conditions outlined below:

TERMS AND CONDITIONS

1. OPERATION AND MAINTENANCE

- 1. The Company shall ensure that the Equipment is properly operated and maintained at all times. The Company shall:
 - a. prepare, before commencement of operation of the Equipment, and update, as necessary, a Manual outlining the operating procedures and a maintenance program for the Equipment, including:
 - i. routine operating and maintenance procedures in accordance with good engineering practices and as recommended by the Equipment suppliers;
 - ii. emergency procedures;
 - iii. procedures for any record keeping activities relating to operation and maintenance of the Equipment; and
 - iv. all appropriate measures to minimize dust, noise and odorous emissions from all potential sources;
 - b. implement the recommendations of the Manual.

2. FUGITIVE DUST CONTROL

- 1. The Company shall develop in consultation with the District Manager, a Best Management Practices Plan for the control of fugitive dust emissions. This Best Management Practices Plan shall:
 - a. at minimum, be prepared in accordance with Ministry Technical Bulletin: Management Approaches for Industrial Fugitive Dust Sources; and
 - b. include a list of all Ministry comments received, if any, on the development of the Best Management Practices Plan, and a description of how each Ministry comment was addressed in the Best Management Practices Plan.
- 2. The Company shall submit the Best Management Practices Plan to the District Manager not later than three (3) months after the date of this Approval or as otherwise indicated by the District Manager.
- 3. Upon acceptance of the Best Management Practices Plan by the District Manager, the Company shall immediately implement the Best Management Practices Plan for the control of fugitive dust emissions to provide effective dust suppression measures to any potential sources of fugitive dust emissions resulting from the operation of the Facility.

4. The Company shall update the Best Management Practices Plan as necessary or at the direction of the District Manager.

3. RECORD RETENTION

- The Company shall retain, for a minimum of two (2) years from the date of their creation, all records and information related to or resulting from the recording activities required by this Approval, and make these records available for review by staff of the Ministry upon request. The Company shall retain:
 - a. all records on the maintenance, repair and inspection of the Equipment; and
 - b. all records of any environmental complaints, including:
 - i. a description, time and date of each incident to which the complaint relates;
 - ii. wind direction at the time of the incident to which the complaint relates; and
 - iii. a description of the measures taken to address the cause of the incident to which the complaint relates and to prevent a similar occurrence in the future.

4. NOTIFICATION OF COMPLAINTS

- 1. The Company shall notify the District Manager, in writing, of each environmental complaint within two (2) business days of the complaint. The notification shall include:
 - a. a description of the nature of the complaint; and
 - b. the time and date of the incident to which the complaint relates.

5. NOISE

- 1. The Company shall, at all times, ensure that the noise emissions from the Facility comply with the limits set out in Ministry Publication NPC-300.
- 2. The Company shall restrict truck traffic activities to the daytime period between 7:00 AM and 7:00 PM.
- 3. The Company shall restrict outdoor operation of forklift or skid steer to the daytime period between 7:00 AM and 7:00 PM.

6. NOISE CONTROL MEASURES

- 1. The Company shall:
 - a. fully implement the Noise Control Measures described in Schedule A of this Approval not later than twelve (12) months from the issuance of an

above grade building permit under the Building Code Act, 1992, for a building containing allowable sensitive uses on the vacant lot located east of the Facility depicted as POR2 in Figure A-1 of the Acoustic Assessment Report; and

b. ensure that the Noise Control Measures are properly maintained and continue to provide the acoustical performance outlined in the Acoustic Assessment Report.

SCHEDULE A

Noise Control Measures

Overhead Doors (OHD3, OHD4, OHD5, OHD6 and OHD7)

1. The overhead doors on the east side of the Facility should remain fully closed at all time.

The reasons for the imposition of these terms and conditions are as follows:

- 1. Conditions Nos. 1 and 2 are included to emphasize that the Equipment must be maintained and operated according to a procedure that will result in compliance with the EPA, the Regulations and this Approval.
- 2. Condition No. 3 is included to require the Company to keep records and to provide information to staff of the Ministry so that compliance with the EPA, the Regulations and this Approval can be verified.
- 3. Condition No. 4 is included to require the Company to notify staff of the Ministry so as to assist the Ministry with the review of the site's compliance.
- 4. Condition No. 5 is included to provide the minimum performance requirements considered necessary to prevent an adverse effect resulting from the operation of the Facility.
- 5. Condition No. 6 is included to require the Company to implement a Noise Control Measures designed to ensure that the noise emissions from the Facility will be in compliance with applicable limits set in the Ministry's noise guidelines.

In accordance with Section 139 of the *Environmental Protection Act,* you may by written notice served upon me, the Ontario Land Tribunal and in accordance with Section 47 of the *Environmental Bill of Rights,* 1993, the Minister of the Environment, Conservation and Parks, within 15 days after receipt of this notice, require a hearing by the Tribunal. The Minister of the Environment, Conservation and Parks will place notice of your appeal on the Environmental Registry. Section 142 of the *Environmental Protection Act*

provides that the notice requiring the hearing ("the Notice") shall state:

- a. The portions of the environmental compliance approval or each term or condition in the environmental compliance approval in respect of which the hearing is required, and;
- b. The grounds on which you intend to rely at the hearing in relation to each portion appealed.

The Notice should also include:

- 1. The name of the appellant;
- 2. The address of the appellant;
- 3. The environmental compliance approval number;
- 4. The date of the environmental compliance approval;
- 5. The name of the Director, and;
- 6. The municipality or municipalities within which the project is to be engaged in.

And the Notice should be signed and dated by the appellant.
