Introduction

This document is complementary to the "Consultation Guide on Proposed Regulations for the Expansion of Administrative Penalties".

The Ministry is proposing that the baseline penalty for each contravention would be pre-determined based on the contravention, which are classified into "types". This is the starting point from which additional factors are considered, as part of the penalty calculation process. The penalty "type" assigns a base penalty range that is related to the seriousness of the contravention.

The tables in this document outline how contraventions have been classified. The tables are broken down into provisions of the Act, provisions of each regulation, and then contraventions of instruments such as environmental compliance approvals. The Ministry has classified all contraventions under each of the following five Acts:

- Environmental Protection Act
- Ontario Water Resources Act
- Safe Drinking Water Act
- Pesticides Act
- Nutrient Management Act

Note 1: The base penalty ranges presented in this document are for corporations. The base penalty ranges for individuals are lower than those for corporations with a ratio of 1 to 5, and a minimum base penalty amount of \$500 before potential penalty reductions.

Note 2: Type LE base penalty amounts reflect a deviation from a legal limit and the penalty amount is related to the magnitude of deviation. In the following tables, for the "Type LE" base penalties, please refer to the Appendix in the "Consultation Guide on Proposed Regulations for the Expansion of Administrative Penalties" for more information.

Note 3: In the tables below, for references with just a section number listed (i.e., no subsection, etc.), the penalty classification details apply to all contraventions within the section.

Instructions – How to Interpret the Tables

Example 1: Nutrient Management Act, O.Reg.267/03: General

Reference	Base Penalty Type	Base Penalty Range
s.20(1), (3)	Type 1	\$500 - \$1,000

Interpretation:

- Subsection 1 and Subsection 3 of Section 20 are Type 1 penalties
- The issuer of the penalty conducts a gravity assessment for "less serious" (\$500), "serious" (\$750), or "very serious" (\$1,000)

Example 2: Pesticides Act, O.Reg.63/09: General
