Adopting By-Law



BY-LAW NUMBER 61-23

- of -

THE CORPORATION OF THE COUNTY OF BRANT

To adopt the County of Brant Official Plan, *A Simply Grand Plan*.

WHEREAS Section 17 of the *Planning Act, R.S.O. 1990, c. P. 13*, as amended (the *Planning Act*), requires municipalities, including The Corporation of the County of Brant, to prepare and adopt an Official Plan and submit it to the Minister of Municipal Affairs and Housing for approval;

AND WHEREAS The Corporation of the County of Brant currently has in effect an Official Plan, as amended, which was adopted by By-law 183-10 on September 7th, 2010, and approved with modifications by the Minister of Municipal Affairs on August 10, 2012;


AND WHEREAS the County of Brant has engaged upon public consultation and has held the required open houses and statutory public meetings for the adoption of an Official Plan;

AND WHEREAS The Corporation of the County of Brant has undertaken an Official Plan Review, including a Municipal Comprehensive Review pursuant to the *A Place to Grow: Growth Plan for the Greater Golden Horseshoe*, as amended, and has prepared the new County of Brant Official Plan, *A Simply Grand Plan*, in accordance with Sections 17, 21 and 26 of the *Planning Act*, to replace the current Official Plan applicable to the County of Brant with a new, updated Official Plan that conforms with Provincial plans, has regard to matters of Provincial interest and is consistent with policy statements issued under the *Planning Act*;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE COUNTY OF BRANT HEREBY ENACTS as follows:

1. In accordance with Section 17(22) of the *Planning Act*, the new County of Brant Official Plan, *A Simply Grand Plan*, and Schedule mapping as set out in Schedule "A" attached hereto, is hereby adopted.
2. The Clerk is hereby authorized and directed to give notice of adoption of the new County of Brant Official Plan, *A Simply Grand Plan*, pursuant to Section 17(23) of the *Planning Act*.
3. The Clerk is hereby authorized and directed to forward the new, Council-adopted County of Brant Official Plan, *A Simply Grand Plan*, and other required documentation to the Ministry of Municipal Affairs and Housing, pursuant to Section 17(31) of the *Planning Act*, for the approval of the new Official Plan.
4. In accordance with Section 17(38.1) of the *Planning Act*; the new Official Plan shall take effect on the day after the day it is approved by the Minister of Municipal Affairs and Housing.



6. This By-law, hereby enacted on the date of passage, shall be effective and apply as of and from the date upon which approval of the Minister of Municipal Affairs and Housing is given on the New Official Plan.

READ a third time and finally passed in Council, this 30th day of May 2023.
