A By-law to adopt Amendment Number 8 to the County of Simcoe Official Plan (Minor Expansion to the Settlement Area of Guthrie, Township of Oro-Medonte)

Whereas Section 21(1) of the Planning Act, R.S.O. 1990, c. P.13, as amended states that a County may amend its Official Plan; and

Whereas by adoption of Item CCW 2024-016 Council deems it expedient to amend the County of Simcoe Official Plan; and

- 2. That the County Clerk is hereby authorized and directed to make application to the Ministry of Municipal Affairs and Housing for approval of Official Plan Amendment Number 8 to the County of Simcoe Official Plan, as adopted by this By-law.
- 3. That the provisions of Amendment Number 8 come into force and effect upon the approval of the Ministry of Municipal Affairs and Housing

THE CONSTITUTIONAL STATEMENT

The following Amendment to the Official Plan for the County of Simcoe consists of two parts.

PART A – THE PREAMBLE consists of the purpose, location and basis for the Amendment and does not constitute part of the actual Amendment.

PART B – THE AMENDMENT sets out the actual Amendment to the County of Simcoe Official Plan.

PART A - THE PREAMBLE

TITLE

The title of this Amendment is "Official Plan Amendment No. 8 to the Official Plan for the County of Simcoe", herein referred to as Amendment No. 8.

PURPOSE

The Amendment proposes to amend Schedule 5.1 Land Use Designations for lands located adjacent to the rural settlement of Guthrie in the Township of Oro-Medonte for the purpose of a minor expansion to the rural settlement.

LOCATION

Official Plan Amendment No. 8 is a site-specific amendment as identified by Part B, affecting lands legally described as East Half of Lot 20, Concession Road 5 Formerly in the Township of Oro, now in the Township of Oro-Medonte.

BASIS

The County of Simcoe has received an application to amend the County of Simcoe Official Plan for a site-specific re-designation of lands from Agricultural to Settlements. The purpose of the amendment is to facilitate a minor expansion to the rural settlement of Guthrie in the Township of Oro-Medonte. The amendment is mapping related only and would affect Schedule 5.1 Land Use Designations in the County of Simcoe Official Plan, where the new boundary limit of the settlement would be identified.

PART B - THE AMENDMENT

1.0 Introduction

This part of the document entitled Part B – The Amendment, which consists of a schedule amendment as detailed in Section 2.0 of Part B, constitutes Amendment No. 8 to the Official Plan for the County of Simcoe.

2.0 Details of the Amendment

Schedule 5.1 Land Use Designations in the Official Plan for the County of Simcoe is hereby amended as follows:
