The Ear Falls project area is road-accessible and workers will drive to exploration sites in light duty vehicles.

The project area is located 10 km north of the town of Ear Falls, ON. From Ear Falls, it is accessible by driving 3.5 km northeast on Highway 657 (Wenasaga Road) and 7 km north on two-lane road along the power line towards Detector Lake. From the power line road, most of the project area can be reached by an existing network of logging roads. The western portion of the project area is accessible by driving 10 km on Highway 105 from Ear Falls.

Approximately 9 km of exploration trail will be constructed to access proposed drill pads and stripping locations. The approximate location of these features are shown on the property maps attached to this application.

How will you be mobilizing/demobilizing equipment to and from the exploration site for all activities? Describe in detail. Diamond drill rig will be disassembled and transported to exploration sites on a flatbed truck or a flatbed trailer towed by pickup truck. The drill rig will be assembled at drill sites. The drill rig will be mounted on a skid and towed by a dozer from one drill site to the next. Once the exploration activities are completed, the drill rig will be dissembled and transported off exploration sites in the same method.

Excavator and dozer will be transported on/off exploration site on a flatbed truck. Hand tools will be carried by pickup truck or trailer hauled behind truck.
