# **NOTICE OF DECISION**

With respect to the Official Plan Amendment № 2021-11 to the Sault Ste. Marie North Planning Board Official Plan Subsections 17(34) & 21 of the Planning Act

A decision was made on the date noted above to approve Official Plan Amendment No 2021-11 to the Official Plan of the Sault Ste. Marie North Planning Board, as adopted by By-law 2021-11.

#### **Purpose and Effect of the Official Plan Amendment**

The purpose of the amendment is to permit the creation of two 0.54-hectare residential lots, which is less than the 0.8-hectare minimum lot size permitted by the official plan.

### When and How to File an Appeal

Any appeal to the Ontario Land Tribunal must be filed with the Minister of Municipal Affairs and Housing no later than 20 days from the date of this notice as shown above as the last date of appeal.

The appeal should be sent to the attention of Zeinab Seifpour, at the address shown below and it must,

- (1) set out the specific part of the proposed official plan amendment to which the appeal applies;
- (2) set out the reasons for the request for the appeal; and
- (3) be accompanied by the fee prescribed under the Ontario Land Tribunal Act, 2021 in the amount of:
  - \$400.00 for a private citizen, a registered charity or a non-profit ratepayers association: or.
  - \$1,100.00 for a corporation,

payable by certified cheque to the Minister of Finance, Province of Ontario.

#### Who Can File An Appeal

Only individuals, corporations or public bodies may appeal the decision of the Ministry of Municipal Affairs and Housing to the Ontario Land Tribunal. A notice of appeal may not be filed by an

unincorporated association or group. However, a notice of appeal may be filed in the name of an individual who is a member of the association or group on its behalf.

Last Date of Appeal:

No person or public body shall be added as a party to the hearing of the appeal unless, before the plan was adopted, the person or public body made oral submissions at a public meeting or written submissions to the council, or, in the opinion of the Ontario Land Tribunal, there are reasonable grounds to add the person or public body as a party.

#### When the Decision is Final

The decision of the Minister of Municipal Affairs and Housing regarding Official Plan Amendment Nº 2021-11 is final if a Notice of Appeal is not received on or before the last date of appeal noted above.
