Subject: In response to the April 5th, Ministry of Natural Resources and Forestry's posting number 013-4992 on the Environmental Registry of Ontario; 'Focusing conservation authority development permits on the protection of people and property'.

Dear Minister Yakabuski,

South Nation Conservation (SNC) ^{by Keith Marenco} has demonstrated a strong history of working with developers, including INSERT NAME, to offer streamlined, convenient and pragmatic approaches to development proposals, local regulation and permit approvals that adhere to their core mandate of protecting people and property from natural hazards. This includes:

- Delivering municipal watershed planning reviews on behalf of member municipalities to determine if development could be susceptible to natural hazards.
- Offering pre-consultation meetings to review development proposals with developers, residents, and municipal staff, leading to more efficient approvals.
- Offering septic and property inquiry services for property owners and developers, providing a record of history to inform valuable decision-making for development.
- Delivering municipal programs through memorandum of understanding agreements, including issuing permits and performing inspections for septic installation and maintenance on behalf of 13 participating municipalities under Part 8 of the Ontario Building Code; SNC delivers this program with exceptional service and hosts an annual septic meeting to engage with local developers.
- Preparing floodplain maps and updating regulated areas for municipalities to guide official plans and zoning by-laws, and guide future development away from flood and erosion-prone areas; SNC holds public open houses and communicates directly with developers and residents to inform updated mapping.
