I am not a \$#*% disturber, but I would like to call attention to an effort by some of my neighbours to address a local concern. Raw sewage is being dumped on designated land along the Zion Line. This has been the practice for many years, and as neighbours, we have not complained. We all produce it and it has to go somewhere.

However, when a new raw sewage dump site went into operation, one of the neighbour's wells was impacted. He and some of this children were sickened by human ecoli. Since this wasn't a problem before the dumping began and cleared up when it stopped, one would be safe in concluding that the raw sewage had a negative impact on the people living in the area. With this new understanding of how the natural water systems work in the area, the conclusions of the environmental impact assessment the government may have conducted to deem that the area was suitable, need to be called into question.

As neighbours, we are not against dumping human waste on local fields. We are asking that the practice be brought up to a standard that is practised elsewhere in the province and that will ensure our health and well-being. We are asking that this sewage be PROCESSED at a sewage treatment facility before it is dumped now that this is possible. This may initially impact the profit margin and practice of the sewage removal services that have not been having the waste processed, but we believe that these companies are community-minded enough to embrace the larger vision of prosperity: the well-being of the environment, the neighbours, and their company and its employees. I don't believe we are unreasonable in asking that the local governance address this issue with a bylaw requiring pre-treatment of sewage. There is evident reason for our concern. Taking action now can prevent long term consequences to the environment, the neighbourhood, and the septic services involved. Can we be foreword thinking and make choices that will ensure a safe, sustainable, and responsible essential service?
