Subject:	ERO #019-6813- Proposed Provincial Planning Statement (PPS 2023) Natural Heritage-Township of Springwater Comments

Report Highlights

- On April 6th, 2023, the Province of Ontario released Bill 97 known as the 'Helping Homebuyers, Protecting Tenants Act'.
- As a result of the legislative changes, the Province initiated a process to revise the Provincial Policy Statement (PPS) to facilitate a more streamlined approach by consolidating the 2020 PPS and the Growth Plan for the Greater Golden Horseshoe resulting in a proposed Provincial Planning Statement.
- Environmental Registry Ontario (ERO # 019-6813) posted an extension to the original commenting period, which now closes on August 4th, 2023.
- Revisions to the PPS incorporating Natural Heritage policies were posted on the ERO on June 16th, 2023 and the changes are generally as follows:
 - Inclusion of a variety of definitions and revisions intended to clarify natural features.
- Staff are generally satisfied with the proposed revisions as they appear to transfer existing policies and clarify definitions associated with various natural heritage features.
- Subject to any comments received from Council, staff do not have any additional comments to provide as a result of the proposed changes to the PPS.
