**RE: ORR # 24-MMAH002 and ERO # 019-8273 Get It Done Act, 2024 - Amending the Official Plan Adjustments Act, 2023**

On behalf of the Ontario Federation of Agriculture (OFA), I am writing to address the proposed amendments to the Official Plan Adjustments Act, 2023. At OFA, we strongly support our municipal counterparts and the provision to allow for flexibility within municipal policy across Ontario. As we have highlighted in previous submissions, municipalities vary across the province, and it is OFA's belief that municipalities should be allowed flexibility within the local policy so long as it is in accordance with provincial policy. We would also like to maintain and reiterate our position that the protection of agricultural land should be prioritized, and best planning practices be promoted across the province.



If our province plans to continue to grow and prosper, we must also have the plan to protect Ontario's position to produce food, fibre, and fuel for the people of this province and beyond.

In addition, OFA urges the provincial government to promote and utilize best planning practices that plan for a sustainable and resilient future for generations to come. Best planning practices promote the harmonious use of our landscape for the foreseeable future, ensuring that we are planning for both the interests of today and tomorrow.

We appreciate the opportunity to provide our feedback and agricultural perspectives on provincial and municipal policies. We look forward to working with the provincial government and our municipal counterparts to sustain our province's housing supply and communities while protecting our agricultural land base and supporting our agri-food sector as an economic powerhouse.
